Elise Niedermeier, ADA Coordinator | Community Outreach and Access Coordinator, Minneapolis Park & Recreation Board (MPRB) and member of the Transgender Equity Council shared an overview of gender inclusion work at MPRB.

Kate Lamers, Project Manager, Minneapolis Park & Recreation Board presented about the Water Works project. The current design includes two single-occupancy all-gender restrooms, and gendered restrooms.

Questions:

- For the architects: Have they considered a wall with just bathroom stalls, and a wall with sinks? To include more bathrooms; anyone can use.
- Is a shared sink area an issue for people based on religious beliefs?

Next: Kate L. and Elise to talk and report back to the Transgender Equity Council (TEC).

Discussion: Next Steps following Oct. 26 facilitated discussion led by Beth Zemsky Ideas:

- Hearing from organizations, including people on the TEC. What they do, how we can be helpful to them, what questions they have for us, and who else we should speak with.
- Community asset mapping for people on the TEC; i.e., sharing bios in writing.
- 4-6 hour retreat?
