A separate license is not required for each horse Hours of operation are subject to the Public Works' parade, festival and Metrodome event restrictions and limited to the hours between 6:00 a.m.-10:00 a.m. and 3:30 p.m.-6:30 p.m. Rates shall be posted on the carriage and visual to entering and seated passengers.
