Operator: 911 what's the address of the emergency?

Caller: Yeah, we're gonna need an emergency over here real quick.

Operator: What's the address of the emergency?

Caller: Ah man ah, ah, it's hard to explain man, you all need to get over here (inaudible—both talking).

Operator: I don't know where you are. I need an address. You have to tell me where you are.

Caller: 314 Thomas AV N.

Operator: 3114 Thomas AV N?

Caller: Yeah.

Operator: Okay, is that a house, apartment, or duplex?

Caller: Ah, it's a house.

Operator: Tell me exactly what happened.

Caller: Ah man, I'm like shaking over and...

Operator: What's going on there?

Caller: Gunshots in [REDACTED] house, man.

Operator: Someone's in [REDACTED] house shooting?

Caller: Well no it's, not who it's [REDACTED] and he's intoxicated right now.

Operator: Okay is [REDACTED]

Caller: (Inaudible).

Operator: Is [REDACTED] shooting?

Caller: Yeah, he was carrying a knife.

Operator: Did he shoot someone?

Caller: (Inaudible—both talking) and outside.

Operator: Did he shoot someone?

Caller: No he just open fire shots man. I'm like scared now.

Operator: Okay.

Caller: We're in the car right now.

Operator: Okay I'm just getting help started, okay? You said no one was hit?

Caller: No, I'm pretty sure not but I'm scared for [REDACTED] because [REDACTED] couldn't taken out, take her out in time and...

Operator: Okay.

Caller: Honestly, I'm really scared for her right now.

Operator: Okay listen, listen to my voice okay, I do have a call entered for officers to come to 3114 Thomas AV N.

Caller: Yeah.

Operator: What's [REDACTED]...what's [REDACTED] name?

Caller: Ah just (inaudible) alright it's 3114 Thomas AV N.

Operator: Yup that's what I have sir, what's, [REDACTED] name is CHISTER(?)?

Caller: Yeah, CHIASHER.

Operator: What's his last name?

Caller: Ah, VUE. V-U-E.

Operator: V-U-E? Spell his first name.

Caller: Ah his name is C-I-A.

Operator: C-H-I-A?

Caller: Uh-huh, S-H-E-R.

Operator: Okay, what's his date of birth?

Caller: Ah, dang let's...

Operator: Okay, that's okay. How, how old is he?

Caller: He's really around like 50 or 60?

Operator: 50 to 60? Okay is he white, black, Hispanic, Native, Asian.

Caller: Ah, he's Asian.

Operator: Okay, 50 to 60 years old? Well how about, how tall is he, how much does he weigh?

Caller: He's probably maybe 5 foot ah...

Operator: Is he thin, medium, or heavyset?

Caller: (Inaudible). Ah what?

Operator: Is he thin, medium, or heavyset? We have help on the way.

Caller: He's medium, medium-set.

Operator: Medium build and what is he wearing?

Caller: Ah he should be wearing his navy sweatpants and stuff like that.

Operator: Sweatpants okay and where is he at in the house?

Caller: Ah last, we saw of him was he was on the second floor.

Operator: Second floor the, is, is he like in a bedroom, hallway, bathroom?

Caller: Hallway maybe.

Operator: Okay and who else is inside the, the house?

Caller: Ah no one, just [REDACTED] right now.

Operator: Just [REDACTED]?

Caller: I'm sorry for my....

Operator: You don't have apologize okay. Just, just stay with me while police are on the way. Was [REDACTED], was he shooting at [REDACTED]?

Caller: No, he just open shots.

Operator: He just, did he like shoot in the air, where did he shoot?

Caller: Probably shot, probably he shot in the air or towards the wall and stuff.

Operator: Okay and what's [REDACTED] name?

Caller: Um, [REDACTED].

Operator: [REDACTED]? Okay what's, what's her last name?

Caller: Ah it should be [REDACTED].

Operator: Okay. Asian female?

Caller: Female.

Operator: Okay and how old is she?

Caller: Yeah. She's maybe around ah 70.

Operator: 70? Okay and, and do you know what's she's wearing?

Caller: Ah, she's wearing like a dress and a shirt.

Operator: Do you know what color of dress she's wearing?

Caller: It's like orange and black, kinda.

Operator: Orange and black dress? Okay and you say you're in a vehicle right now?

Caller: Yeah [REDACTED], are across the street because we, we don't feel safe, man. We, I feel afraid but like I'm like scared right now.

Operator: I understand, I understand you are afraid okay, that's perfectly normal. Do you remember what kind of gun he has?

Caller: Ah, I didn't see I was, I was trying to, I'm not trying to stick around to find out you know.

Operator: That, that yup, that's fine. So, you don't know the, okay. How many shots did he fire?

Caller: I don't recall but sounded to me he like three or four.

Operator: Okay and you said you guys are currently across the street right now?

Caller: Yes, we're in a white Toyota.

Operator: White Toyota?

Caller: Or silver Camry, yeah.

Operator: A white or silver Toyota Camry?

Caller: Ah silver (inaudible).

Operator: And who else are you with?

Caller: [REDACTED].

Operator: Okay and what's your name?

Caller: Um, [REDACTED].

Operator: [REDACTED] okay. Are you guys able to move or drive away from the house right now for your safety?

Caller: Ah yeah.

Operator: Okay, just drive like a couple blocks away and let me know exactly where you're gonna be parked at, okay [REDACTED]?

Caller: Okay ah, I'll tell [REDACTED] then to drive maybe to the ah, ah FAMILY DOLLAR that's right up the street.

Operator: Okay, just let me know when you get there okay?

Caller: Okay.

Operator: Just stay on the line with me okay?

Caller: Okay (Uh Family Dollar. On your left)

Operator: Yeah as soon as you get there [REDACTED] let me know so I can let my officers know.

Caller: Okay.

Operator: Okay.

Caller: Yeah, we just passed the cops so.

Operator: Okay [REDACTED]...

Caller: Do you just want us to keep going?

Operator: Nope, nope some...

Caller: (Inaudible—both talking).

Operator: I'm going to tell you exactly where to go. So, the police want you to meet at Lowry and Thomas, do you know where that is?

Caller: No but I told [REDACTED]. Ah, they want to meet at Lowry and Thomas.

Operator: Yup and I'll let my officers know that you are, you were advised of that, okay?

Caller: Okay.

Operator: Just let me know when you get to Lowry and Thomas.

Caller: Okay ah just Lowry and Thomas. (Yeah, she just said go to Lowry and Thomas so...)

Operator: Yup and a squad will meet you there. It should be squad #425.

Caller: Okay ah we're (inaudible). Ah...

Operator: Where are you currently right now [REDACTED]?

Caller: Ah we are ah going up. Okay I think we see the officer.

Operator: Okay are you on Lowry and Thomas?

Caller: Yeah.

Operator: Okay, go ahead and pull up. I won't hang up until I hear the officer in the background.

Caller: (Ah, ah, go to the officer). Ah, we see them.

Operator: Okay, are you speaking with them?

Caller: No, we just found [REDACTED].

Operator: Okay, I'll wait until you actually, physically speaking with an officer before I disconnect.

Caller: Okay, well ah we're running towards them. (He's talking.) Okay yeah, we see them.

Operator: You got to them? Okay [REDACTED] I'm gonna disconnect from you okay?

Caller: Okay, alright.

Operator: Okay.
