The prime bidder must then submit a Final SUBP Commitment Form (due by 5 pm on the first business day after the City bid opening), which will specify what MBE and WBE firms the prime will use to meet the goal(s). In that Final SUBP Commitment Form, the prime bidder may NOT adjust its MBE and WBE commitments downwards, but may adjust its commitments upwards.
- 6. Failing to complete and submit this form, or indicating "not applicable," will result in a non-responsive bid.
