On June 23rd at 5:26 pm, Officers responded to a report of a person shooting a weapon into the air in the area of the 4700 block of Bryant Avenue North.

Officers from the Minneapolis Police Department arrived and observed the suspect. A foot chase ensued and shots were fired. The suspect was pronounced dead at the scene. Officers involved in this incident were wearing body cameras that were activated.
