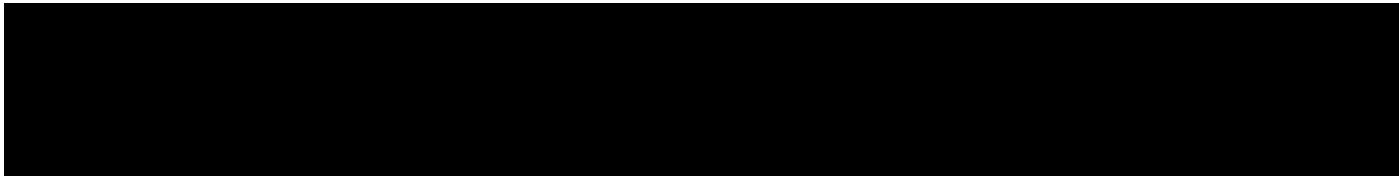

On December 30, 2020 at approximately 6:15 pm, officers from the Minneapolis Police Department attempted to stop a vehicle on the 3500 block of Cedar Avenue South in regard to a weapons investigation.

The suspect vehicle attempted to flee from officers in squads and on foot. Squads attempted to maneuver into a position to block the suspect vehicle from fleeing and contact was made between squads and the suspect vehicle. Verbal commands were given to the suspect and gunfire was exchanged. Officers discharged their duty side arms.

The suspect, Dolal Bayle Idd, 23, was pronounced deceased at the scene. No officers were physically injured as a result of the incident.
