At approximately 5:28 p.m. officers from the 2nd Precinct were dispatched to the 3400 block of 5th St NE to investigate a 911 hang-up call. While outside the address, officers observed people inside the residence and attempted to communicate with the individuals through a window. The individuals directed the officers to the rear of the house. Officers located an unlocked rear door, announced their presence, and entered the home. Officers heard cries of distress. One of the officers was confronted by an adult male pointing a gun at him. Gunfire was exchanged. The officers moved outside. Officers secured the scene as an adult female, a juvenile female, and a juvenile male left the house. The officers went back inside and identified an adult male in his 50s with an apparent fatal gunshot wound lying on the floor. A gun was recovered. The officer who exchanged gunfire was transported to the hospital, treated, and released. Both officers wore body-worn cameras that were on and active. MPD requested the Bureau of Criminal Apprehension (BCA) to respond. The BCA has begun an independent investigation into this incident.
