Program Overview

Parklets and Street Cafes* are seasonal public spaces that make the city more livable and walkable. They add space to our streets where people can gather, relax, and interact. This program enables and empowers community groups and businesses to transform underutilized street space into a vibrant public space that is accessible and open for all.

*Street Cafes are not public spaces but function as an extension of the business, therefore they may follow the operations of the host business.

Parklets

City-owned Parklets

Parklets and Street Cafes* are seasonal public spaces that
make the city more livable and walkable. They add space to

vibrant public space that is accessible and open for all.

Community Parklets

 Community groups or businesses can design and create their own parklet space following the City's Parklet Manual. All parklets must be accessible and open to all. Advertising and other commercial activities are not permitted in City-owned parklets.

Street Cafes

 Businesses can design and create their own space following the City's Parklet Manual and Street Cafe supplement document. Street cafes function as an extension of the business. Street cafes are permitted to allow seating for restaurant customers are not open to the public.




Design & Site Requirements

All parklets and street cafes must follow the design and site requirements outlined in the Parklet Application Manual.


Sidewalk Level

Sidewalk level parklets use a platform that is flush with the sidewalk. This option is generally more accessible to all parklet users as the space can be accessed from anywhere along the platforms/sidewalk. Design guidelines and criteria for sidewalk level parklets can be found in the Parklet Application Manual.



Street Level

Street level parklets allow applicants to put tables and chairs directly on the street without having to build a platform. This option is generally lower cost and can be used to test out the concept of having a parklet or street cafe before investing in a structure. Street level parklets must have an ADA accessible ramp directly into and out of the parklet as well as provide enough space for a wheelchair to turn around. Design guidelines and criteria for street level parklets can be found in the Parklet Application Manual.



Application Process & Timeline

Before getting started with the application process, please review all Parklet and Street Cafe program materials to understand all program requirements.

If you are interested in hosting a City-owned parklet, you must submit your confirmation of eligibility form during the open application window (generally in early March - City staff will send out a notification).

If you are interested in hosting a Community parklet or street cafe, the City generally accepts applications on a rolling basis; however, staff generally review in March/April.

Application Timeline

All applicants

- 1 Submit confirmation of eligibility form to ensure your site meets minimum requirements.
- Once site is approved, submit full application.

ty Parklets & Street Cafe applicants

- Site visit with city staff to discuss traffic, operations, or design considerations for your site.
- 4 Submit final parklet/street cafe plans.
- Once plans are approved, submit all necessary permits and agreements (more details in the Parklet Application Manual and Street Cafe Supplement).

6 Install parklet/street cafe after spring street sweeping.

All applicants

- 7 City inspection.
- 8 Enjoy for the season.
 - 9 Remove parklet/street cafe at the end of the season.
